In addition, you must sign, in the presence of the institutional official, the Statement of Educational Purpose provided below.

If you are unable to appear in person at Wilmington University to verify your identity, The Identity and Statement of Educational Purpose is to be signed in the presence of a Notary and returned to Wilmington University via US Mail (faxed or emailed submissions cannot be accepted). In addition, you must provide:

- (a) A copy of the valid government-issued photo identification (ID) that is acknowledged in the notary statement below or that is presented to a notary, such as, but not limited to, a driver’s license, other state-issued ID, or passport; and
- (b) The original Statement of Educational Purpose, which is provided below, must be notarized. If the notary statement appears on a separate page from the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
