If you are unable to appear in person at Wilmington University to verify your identity, The Identity and Statement of Educational Purpose is to be signed in the presence of a Notary and returned to Wilmington University via US Mail (faxed or emailed submissions cannot be accepted). In addition, you must provide:

- (a) A copy of the valid government-issued photo identification (ID) that is acknowledged in the notary statement below or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport; and
- (b) The original Statement of Educational Purpose, which is provided below, must be notarized. If the notary statement appears on a separate page from the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
